<u>Home 4 Good Homelessness to Housing Response Framework Proposal-presented by Dennis LaCaria</u> (Co-Chair):

- New partners within the community are joining the meetings
- Working to identify challenges
- Working toward finding options, programs, policies, opportunities to assist with homelessness
- Moving toward breaking down silos which encompass more permanent and supportive housing in the community

<u>State of Housing Instability and Homelessness Report Presentation (presented by Courtney LaCaria/Bridget Anderson):</u>

- 2020 is the 5th year of reporting this information
- Key Findings (Housing Instability, Homelessness, Stable Housing)
- Content (Cost burden, renters cost-burden is increasing across income levels, rental housing is shrinking, demand for rental assistance increased 907% in first two months of pandemic, 3,111 individuals are actively experiences homelessness in Charlotte, 4,118 CMS students are experiences homelessness, multiple barriers to obtaining housing(*income*physical/mental health*evictions*criminal record), rapid rehousing and permanent housing has decreased, low-income households rent units at higher cost than they can afford, 44% of households with subsided vouchers are denied, COVID -19 economic insecurity has increased 98% since Feb 2020, and housing instability is higher for Blacks and Latinx households.
- So, What: *Inventory is decreasing in Charlotte and the housing need is increasing*extremely low income households face largest gaps*barriers limit access to available housing*housing instability & homelessness are a problem in Charlotte Pre-Date COVID 19*
- The Message: Our Ship is Sinking***There is not enough permanent affordable housing in Charlotte
