2021 POINT-IN-TIME COUNT (PIT) SHELTERED & UNSHELTERED COUNT METHODOLOGY

The following methodology outlines provide a basic overview of the parameters around how the sheltered and unsheltered counts will be planned, executed and reported back to the community.

SHELTERED COUNT METHODOLOGY

- The CoC will conduct a census (complete coverage) consistent with HUD standards and guidance.
- The CoC will verify that sheltered homeless persons identified in the count are sheltered on the night designated for the count, as defined at 24 CFR 578.3 of the Homeless Definition Final Rule:

"An individual or family living in a supervised publicly or privately operated shelter designated to provide temporary living arrangement (including congregate shelters, transitional housing, and hotels and motels paid for by charitable organizations or by federal, state or local government programs for low-income individuals."

- The CoC will use client data collected and entered in HMIS as the primary data source for the sheltered Point-in-Time Count for emergency shelter and transitional housing projects that participate in HMIS.
- All non-HMIS emergency shelter and transitional housing projects will utilize a comparable database (secure excel spreadsheet) to send their complete census count, utilizing the methodology for non-HMIS Agencies as recommended by HUD and outlined by the HMIS System Coordinator.
- As outlined by HUD guidance, the CoC will coordinate the sheltered Point-in-Time Count closely with the Housing Inventory Count. All homeless services providers in the sheltered count will be included in the Housing Inventory Count and all persons served in those projects on the night of the Point-in-Time Count will be included in the sheltered count. All sheltered homeless providers will be included on the Housing Inventory Count even if they do not participate in HMIS.

UNSHELTERED COUNT METHODOLOGY

• To ensure the health and safety of survey interviewers and respondents during the pandemic, the CoC will use HMIS data to generate an unsheltered count census on the night of the Point-in-Time Count consistent with 2021 HUD standards and guidance. This option allows for the most accurate unsheltered estimate when compared with other non-survey options; and enables the CoC to prioritize safety. To ensure that this estimate is as accurate as possible, an aggregate unsheltered count total will be developed from participants enrolled in HMIS street outreach projects and participants with an open program entry in the community Coordinated Entry (CE) HMIS project that reported during their CE assessment that they had stayed the night before in a place not meant for habitation whom the CoC was able to verify stayed in a place not meant for

habitation on the night of the PIT count. Follow-up communication for the purpose of verification will be conducted virtually for individuals enrolled in CE projects. Street Outreach staff will conduct follow-up verification as necessary with individuals enrolled in Street Outreach projects.

- In addition, Street Outreach and PATH providers will enter data into an unsheltered PIT
 project in HMIS to capture data for any individuals that staff encounter during their
 normal street outreach activities for the 14-day period after the PIT Count. This will
 enable the CoC to count any individual that is not in HMIS already.
- The CoC will verify that unsheltered homeless persons identified in the count are unsheltered on the night designated for the count as defined at 24 CFR 578.3 of the Homeless Definition Final Rule:

"An individual or family with a primary nighttime residence that is a public or private place not designed for or ordinarily used as a regular sleeping accommodation for human beings, including a car, park, abandoned building, bus or train station, airport, or camping ground."

• The table below outlines the process and timeline for conducting the unsheltered count:
