#### Challenges:

Melissa (Re-entry Housing Alliance)---happy to share what they've done. Have standing meetings already around this issue. Policy stuff that is ongoing.

James Searcy (Promise Resource Network)--most people go into prison homeless and it is never addressed. No verified home release plan. Still homeless once they get back to Mecklenburg County. Struggle to find housing. Those with mental health conditions that are not addressed.

Hope Marshall (Mecklenburg County Re-Entry Services)—sex offenders; some housing available but not much; male head of households with children—nowhere for them to go once released and children are placed in their custody. Female sex offenders—no place for them to go. Two predatory housing programs—people are put out to panhandle and have a quota to meet. Older aging men with chronic health conditions.

Mary Quinn (Common Wealth Charlotte)—first month's rent and deposit is difficult, not exhaust their resources immediately—they've come up with a housing opportunity loan---up to \$1000, for 12 month loan or up to \$2000 for 24 month loan. Payments posted to all three credit reports.

Renee Johnson (Triumph Services; City Council member)—lack of housing inventory; landlords not accepting those with criminal backgrounds.

Melissa-

Concerns from those she's worked with:

FRAMING THE ISSUE; This is a CRISIS; No such thing as affordable housing; It's a struggle out there; It's all about the past; "Charged 20 years ago – still having trouble"; "Thirty-year-old conviction and a doctoral degree, and still the charges come up"; Some people need second, third, fourth, fifth chances....Rent is so high in safe neighborhoods; Section 8 [housing assistance vouchers] helps temporarily; [People with records] don't qualify for some resources; A person with a felony is not a

career criminal; [People with records] need choices, different pathways for self-determination; Non-profits get calls every day about reentry homes (not clear on the point here?)

PERSONAL CHALLENGES: Not having a home is traumatic; This is about people; Can't find housing [often leads] to losing [custody] of kids; Children are traumatized; Application fees takes money away from [providing for] children; Rent goes up / stability [goes down]; People die, people lose children;
