CoC Governing Board Meeting Minutes December 15, 2022

The meeting of the CoC Governing Board was held on December 15, 2022, as a hybrid in-person/virtual meeting. The in-person portion was held at the Valarie Woodard Center; Virtual was held via Zoom. Anna London, Board Chair called the meeting to order at 2:03pm.

Welcome (Anna London), Attendance (Branden Lewis): Quorum present. Members of the public introduced themselves with name and organization.

Vote: Adopt meeting agenda (Motion: Jane Shutt, Second: Deronda Metz) – meeting agenda was adopted.

Executive Committee Report Out (Anna London):

- Board Member Survey Please complete survey from Rosalyn Allison-Jacobs to inform the agenda for the CoC Board retreat
- 2023 Board Slate Nominating Committee will conduct interviews for four seats next week. Full membership will approve slate. Afterwards, the board will nominate officers for 2023.
- **Vote:** Adopt 2023 CoC Board meeting calendar (Motion: Karen Pelletier, Second: Tchernavia Montgomery) 2023 CoC Board meeting calendar was adopted.
- **Vote:** Approve meeting minutes: November 17, 2022 (Motion: Deronda Metz, Second: James Lee) meeting minutes were approved.

Home for All Framework Implementation Update (Kathryn Firmin-Sellers): Second Technical Committee meeting held early in December. The goal was to prioritize the most realistic and impactful initiatives. Next step is to reconvene in January and put cost estimates to each prioritized initiative.

Homeless Services Network Update (Randall Hitt): Randall gave an overview of HSN and 2022 programming. HSN held an in-person conference and advocated for improved discharge planning with the local hospital systems for those experiencing homeless.

Chronic Homelessness Workgroup Report Out (Karen Pelletier): Karen presented a proposal to provide Housing First training to our entire community to ensure fidelity to the model. We currently have \$86,945 remaining of a \$149,219 planning grant, which will expire on 1/31. The next planning grant starts on 2/1/23 and is for \$162,063. Vote: Approve utilizing planning grant funds for community

Housing First Trainings & TA (Motion: Kaedon Grinnell, Second: Deronda Metz) – proposal was approved.

Coordinated Entry Oversight Committee Report Out (Hope Marshall): Hope provided data and feedback about CE. She reminded providers that consumers should call the CE Hot Line at 704.284.9665, instead of 211.

Collaborative Applicant Staff Updates (Branden Lewis, Erin Nixon):

- **1. HMIS Software:** Mary Ann Priester reviewed the RFP process and asked the CoC to approve a move to Bit Focus. **Vote:** Approve HIMS sub-committee's recommendation to move Bit Focus (Motion: Kathryn Firmin-Sellers, Second: Jane Shutt) motion was approved.
- 2. Landlord Engagement System Work: Erica Snyder met with members of the community over two days. The community leaned toward having landlord engagement sit with one agency and keeping housing navigation at individual agencies. We will test some of these strategies with the Emergency Housing Vouchers.
- **3. Point In Time Count:** January 26, 2023, everyone encouraged to participate/volunteer. We need over 100 volunteers.

Public Comment: No one signed up for public comment

Agency Updates (All):

Karen Pelletier: At January board meeting, Karen can give an update on the winter shelter plan. The County will use ARP funds to hire more CE staff.

James Lee: Advocate training class will begin in January.

Kathryn Firmin Sellers: Home For All is still recruiting a co-chair for the Advisory Committee.
