Provider Updates

VA: No major updates – scheduling intakes for VASH in CLT. Don't have a lot of vouchers available. Continuing to assist vets with searching for housing. Check email for note from Brittany regarding VAMCs outreach.

SSVF: No updates from CC – on pause, prevention is case by case. CC are hiring – Case Aid, and Shallow Subsidy and Housing Navigator. VSC – working through waitlist

GPD/Contract: Dr. Tamara Neely – Home Care for the Carolinas Contract beds. Normally sees patients on Tuesdays so isn't usually able to join HoH. Have 12 contract beds – 6 medical and 6 non-medical. Almost everyone graduated and moved into housing recently. Have 3 open beds for medical and have 2 beds for non-medical.

CoC: PIT was last week – thank you to everyone. HUD announcements came out yesterday. 1 new provider and everyone else was renewed. Curry is attending the 2024 VA Homeless Program National Conference in April. Community planning section on the agenda.

ARPA: Halfway through the grant cycle. As of today, there are 133 veteran households that have been assisted.

Other Updates:

VBH is participating in a program with Crisis Assistance to provide new appliances for veterans in need. Washers/dryers, dishwasher, fridge or a stove. They have 5 slots available for this. Need to have measurements to ensure it will fit. Need to find a different method for transportation – it's on the veteran/referral agency.

Discussion on Current Projects / Previous Proposals / Getting Baseline Data and Setting New Priorities

Updates on Current Projects: Curry is paring the lists provided from Unite Us down to just be focused on the local resources and to find resources that are not in Unite Us. This should be a good resource guide to provide to veterans to support their housing stability.

1. Outflow:

- a. SSVF: Think it's still a priority to get SSVF to get referrals from the CE process/from the BNL. 50% of referrals should come from BNL. Some veterans are getting overlooked.
- Voucher Utilization: Could we consider lower barrier PSH especially for sex offenses? Might now be in a place to request additional vouchers since the VA is staffed up.
- New priority to consider: Landlord
 Engagement/Partnership Home for All plan will be working on this more broadly. Includes risk mitigation, bonuses for landlords

2. Inflow:

 a. Service Providers (VASH/SSVF): The VA has moved away from no longer allowing vets to be rehoused in VASH if they were evicted/voucher expires. VASH team now is continuing to work with these vets.
